97 年 8 月 15 日 — 京元電子股份有限公司公告(TAIEX 代號: 2449) 97 年第 2 季營收為 NT\$3,628 百萬元，與前一季比較成長 3.6%，與 96 年同期比較成長 15.5%。

京元電子公告 97 年第 2 季本期淨利 NT\$ 489 百萬元；前一季淨利為 NT\$ 321 百萬元及 96 年第 2 季淨利為 NT\$ 258 百萬元。

97 年第 2 季不含合併之財務摘要

- 營業收入淨額為 NT\$ 3,628 百萬元，銷貨成本為 NT\$ 2,730 百萬元，營業毛利為 NT\$ 898 百萬元，營業毛利率為 24.8%
- 營業費用為 NT\$ 323 百萬元，其中包括推銷費用為 NT\$ 43 百萬元，管理及總務費用 NT\$ 201 百萬元，及研究發展費用 NT\$ 78 百萬元。營業淨利為 NT\$ 576 百萬元，營業淨利率為 15.9%。

資本支出及折舊費用資訊

- 97年第2季資本支出為 NT\$ 2,233 百萬元，用於購買測試相關設備及興建廠房。本期折舊費用則為 NT\$ 1,489 百萬元。

測試業務資訊

- 97年第2季邏輯測試相關產品佔總營收比例為 65.7%，較上一季 64.3%，成長 1.4%；記憶體相關產品測試佔總營收比例為 26.4%，較上一季的 27.7%，減少 1.3%；
- 晶圓級測試佔總營收比例為 47.6%，較上一季的 51.7%，減少 4.1%。積體電路成品測試佔本季佔總營收的 44.5%，較上一季的 40.3%，成長 4.2%。

King Yuan Electronics Co., Ltd reports 3.6% Revenues Growth and EPS of NT \$ 0.41 for 2Q 2008

Hsinchu, Taiwan, August 15, 2008 — King Yuan Electronics Co., Ltd (“KYEC” or the “Company”) (TAIEX: 2449) today announced that its sales revenues for 2Q 2008 was NT\$ 3,628 million, representing 3.6% of QoQ growth and 15.5% of YoY growth.

KYEC reported a net income of NT\$ 489 million for 2Q 2008, compared to a net income of NT\$ 321 million for 1Q 2008 and a net income of NT\$ 258 million for 2Q 2007.

Unconsolidated 2Q 2008 Financial Results

- Net sales was NT\$ 3,628 million, cost of goods sold was NT\$ 2,730 million, and gross profit was NT\$ 898 million; representing a gross margin of 24.8%.
- Operating expense was NT\$ 323 million, including selling expenses of NT\$ 43 million, administrative expenses of NT\$ 201 million, and R& D expenses of NT\$ 78 million. Operating profit was NT\$ 576 million, representing an operating margin of 15.9%.
- Net income was NT\$ 489 million.
- Earnings per share this period was NT\$ 0.41. Total weighted average outstanding ordinary shares for the same period were 1,184 million shares.

Capital Expenditure

- Capital spending in 2Q 2008 reached NT\$ 2,233 million to be spent on purchase of equipment and construction of the new plant. The depreciation expenses for the same period were NT\$ 1,489 million.

Revenue Breakdown

- For 2Q 2008, testing of logic products accounted for 65.7% of total revenue, about 1.4% of increase from previous quarter. Testing of memories accounted for 26.4% of total revenue, about 1.3% of decline from previous quarter.
- Revenue from wafer level testing accounted for 47.6%, about 4.1% of decline from previous quarter. Final testing of IC accounted for 44.5%, about 4.2% of increase from previous quarter.
