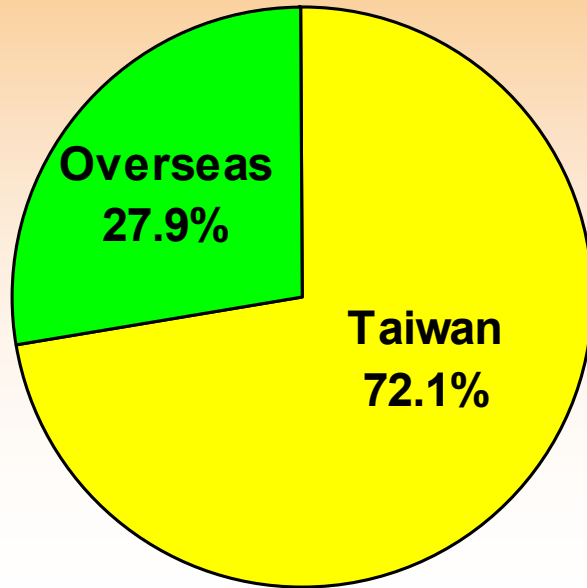

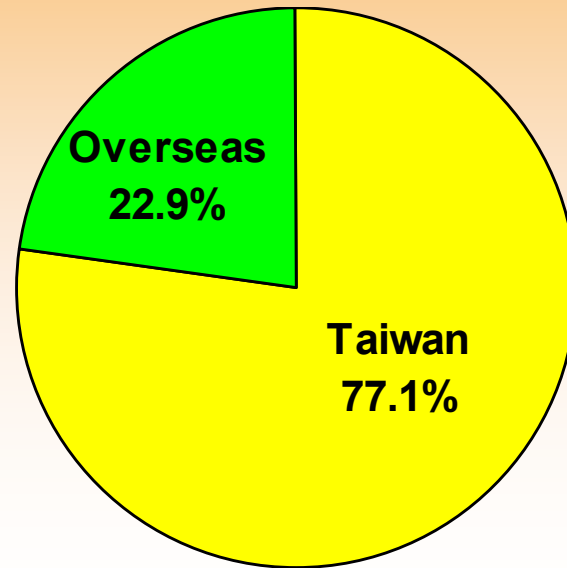

# Sales Breakdown by Geography



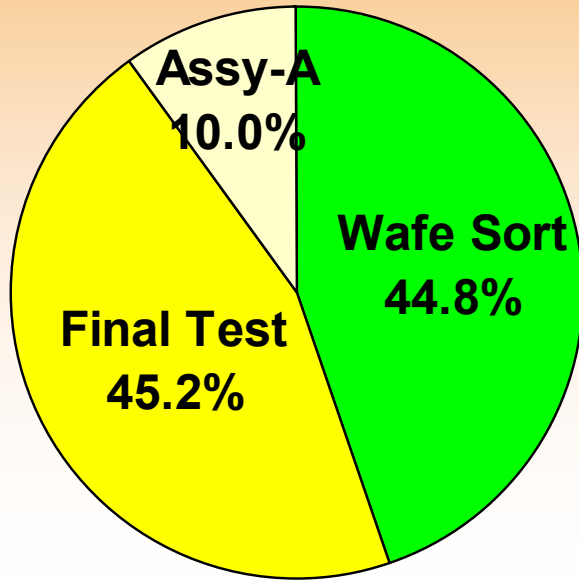

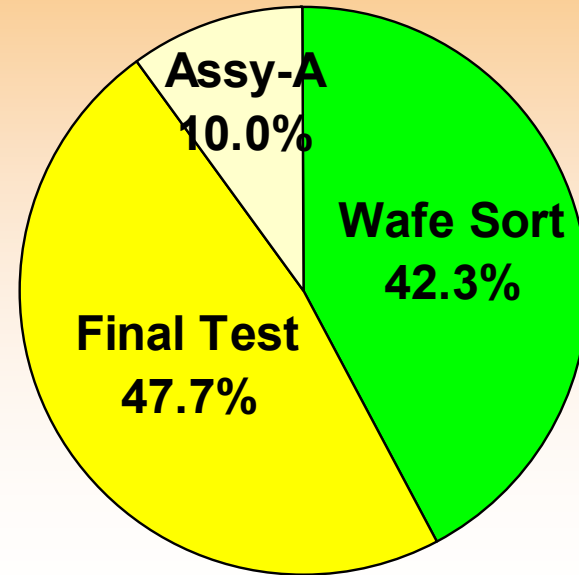

# Sales Breakdown by Process

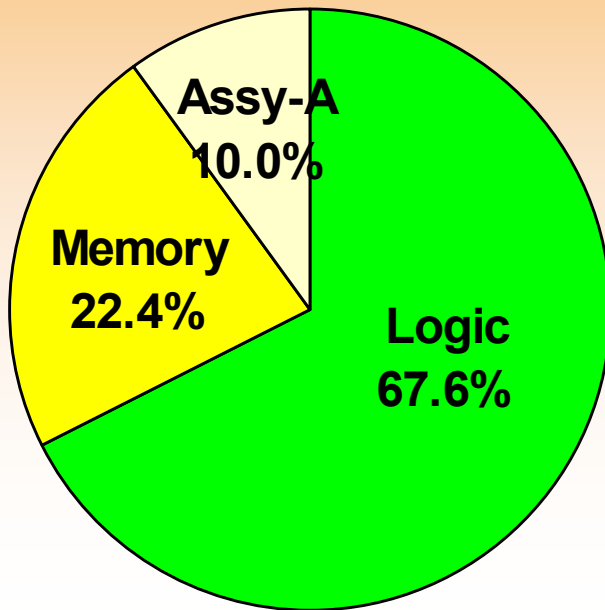

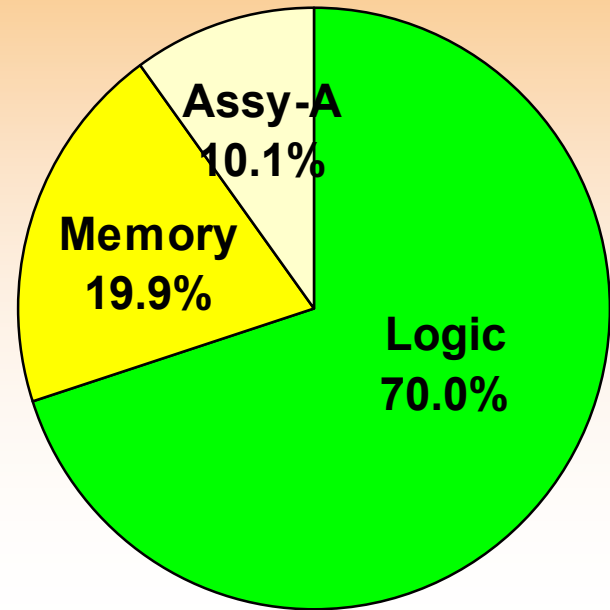
