京元電子公告 98 年第 4 季本期淨利 NT\$236.3 百萬元；前一季淨利為 NT\$192.5 百萬元及 97 年第 4 季淨損為 NT\$807.9 百萬元。

- 晶圓級測試佔總營收比例為 44.4%，較上一季的 44.8%，減少 0.4%。積體電路成品測試佔本季佔總營收的 47.7%，較上一季的 45.2%，成長 2.5%。

King Yuan Electronics Co., Ltd reported 7.2% QoQ Revenues Growth and EPS of NT\$0.19 for 4Q 2009

Hsinchu, Taiwan, March 26, 2010 — King Yuan Electronics Co., Ltd (“KYEC” or the “Company”) (TAIEX: 2449) today announced that its sales revenues for 4Q 2009 was NT\$3,352.1 million, representing 7.2% of QoQ growth and 44.6% of YoY growth.

KYEC reported a net income of NT\$236.3 million for 4Q 2009, compared to a net income of NT\$192.5 million for 3Q 2009 and a net loss of NT\$807.9 million for 4Q 2008.

Unconsolidated 4Q 2009 Financial Results

- Net sales was NT\$3,352.1 million, cost of goods sold was NT\$2,602.3 million, and gross profit was NT\$749.8 million; representing a gross margin of 22.4%.
- Operating expense was NT\$332.4 million, including selling expenses of NT\$55.1 million, administrative expenses of NT\$198.2 million, and R& D expenses of NT\$79.1 million. Operating profit was NT\$417.4 million, representing an operating margin of 12.5%.
- Net income was NT\$236.3 million.
- Earnings per share this period was NT\$0.19. Total weighted average outstanding ordinary shares for the same period were 1,227.3 million shares.

Capital Expenditure

- Capital spending in 4Q 2009 reached NT\$587.2 million to be spent on purchase of equipment. The depreciation expenses for the same period were NT\$1,562.6 million.

Revenue Breakdown

- For 4Q 2009, testing of logic products accounted for 67.2% of total revenue, about 0.4% of decline from previous quarter. Testing of memories accounted for 24.9% of total revenue, about 2.5% of increase from previous quarter.
- Revenue from wafer level testing accounted for 44.4%, about 0.4% of decline from previous quarter. Final testing of IC accounted for 47.7%, about 2.5% of increase from previous quarter.
