99 年 4 月 28 日 — 京元電子股份有限公司公告(TAIEX 代號: 2449) 99 年第 1 季營收為 NT\$3,340.8 百萬元，與前一季比較減少 0.3%，與 98 年同期間比較成長 140.4%。

京元電子公告 99 年第 1 季本期淨利 NT\$278.4 百萬元；前一季淨利為 NT\$236.3 百萬元及 98 年第 1 季淨損為 NT\$1,210.7 百萬元。

99 年第 1 季不含合併之財務摘要

- 營業收入淨額為 NT\$3,340.8 百萬元，銷貨成本為 NT\$2,670.2 百萬元，營業毛利為 NT\$ 670.5 百萬元，營業毛利率為 20.1%
- 營業費用為 NT\$326.4 百萬元，其中包括推銷費用為 NT\$50.5 百萬元，管理及總務費用為 NT\$197.3 百萬元，及研究發展費用 NT\$78.6 百萬元。營業淨利為 NT\$344.1 百萬元，營業淨利率為 10.3%。

資本支出及折舊費用資訊

- 99年第1季資本支出為 NT\$841.2 百萬元，用於購買測試相關設備。本期折舊費用則為 NT\$1,546.3 百萬元。

測試業務資訊

- 99年第1季邏輯測試相關產品佔總營收比例為 69.0%，較上一季的 67.2%，增加 1.8%；記憶體相關產品測試佔總營收比例為 22.6%，較上一季的 24.9%，減少 2.3%；
- 晶圓級測試佔總營收比例為 44.9%，較上一季的 44.4%，增加 0.5%。積體電路成品測試佔本季佔總營收的 46.8%，較上一季的 47.7%，減少 0.9%。

King Yuan Electronics Co., Ltd reported 0.3% QoQ Revenues decline and EPS of NT\$0.23 for 1Q 2010

Hsinchu, Taiwan, April 28, 2010 — King Yuan Electronics Co., Ltd (“KYEC” or the “Company”) (TAIEX: 2449) today announced that its sales revenues for 1Q 2010 was NT\$3,340.8 million, representing 0.3% of QoQ decline and 140.4% of YoY growth.

KYEC reported a net income of NT\$278.4 million for 1Q 2010, compared to a net income of NT\$236.3 million for 4Q 2009 and a net loss of NT\$1,210.7 million for 1Q 2009.

Unconsolidated 1Q 2010 Financial Results

- Net sales was NT\$3,340.8 million, cost of goods sold was NT\$2,670.2 million, and gross profit was NT\$670.5 million; representing a gross margin of 20.1%.
- Operating expense was NT\$326.4 million, including selling expenses of NT\$50.5 million, administrative expenses of NT\$197.3 million, and R& D expenses of NT\$78.6 million. Operating profit was NT\$344.1 million, representing an operating margin of 10.3%.
- Net income was NT\$278.4 million.
- Earnings per share this period was NT\$0.23. Total weighted average outstanding ordinary shares for the same period were 1,219.7 million shares.

Capital Expenditure

- Capital spending in 1Q 2010 reached NT\$841.2 million to be spent on purchase of equipment. The depreciation expenses for the same period were NT\$1,546.3 million.

Revenue Breakdown

- For 1Q 2010, testing of logic products accounted for 69.0% of total revenue, about 0.5% of increase from previous quarter. Testing of memories accounted for 22.6% of total revenue, about 2.3% of decline from previous quarter.
- Revenue from wafer level testing accounted for 44.9%, about 0.5% of increase from previous quarter. Final testing of IC accounted for 46.8%, about 0.9% of decline from previous quarter.
